GENERAL OBJECTIVE

- Supporting educational, professional and personal development of people of all ages in education, training, youth and sport, in Europe and beyond

- Mobility – Cooperation – Policy Development

Implementing mode

- Indirect (National Agencies) and Direct (EAC/EACEA)

How to take part in Erasmus+

- **As individual** : KA1 – Learning mobility for individuals
It's likely that you will need to apply through an organisation such as your university, training centre, company and so on.
- **As applicant organisation** - applying for a project grant or call for proposals
In general terms, the Programme is open to **any organisation active in the fields of education, training, youth or sport.**
Several Actions are also open to the participation of other players in the labour market.

LLLP involvement in Erasmus+

- EU projects
- Promotion of the Erasmus+ programme (as part of the work plan funded by the Programme's operating grant)
- LLLP follows up on the advancement of Erasmus+ and advocates for a better access and transparency of the programme and more coordination and harmonisation between National Agencies.
- Every three years, LLLP conducts the Erasmus+ Implementation Survey, recognised by the EU Commission and Parliament as a direct channel to improve the programme in light of grassroots needs
- In partnership with the European Youth Forum, it also runs a Coalition of Stakeholders that aim to share the views of stakeholders on the Mid-Term Review of the Multiannual Financial Framework and of the EU programmes
